TERMS OF WIRELESS NATION INVOICE PAYMENT AGREEMENT

1. Provision of the PGG Wrightson Wireless Nation Invoice Payment Agreement is only available to current PGG Wrightson Monthly Trade Account holders, and is subject to approval by PGG Wrightson Limited.
2. PGG Wrightson can withdraw approval for billing if you exceed your PGG Wrightson credit limit and/or don't pay PGG Wrightson by the 20th of the month following, and/or if you don't adhere to PGG Wrightson's Customer Terms of Trade (see www.pggwrightson.co.nz > View our Customer Account Terms).
3. If PGG Wrightson withdraws their approval, or if you close your account with PGG Wrightson, you will move to Wireless Nation standard pricing and may be subject to a credit check.
4. PGG Wrightson will bill your PGG Wrightson account the monthly amounts owing on your Wireless Nation account, after receiving this information from Wireless Nation.
5. PGG Wrightson will pay Wireless Nation for any amounts due on your Wireless Nation account, even if an amount is disputed by you. You must pay PGG Wrightson the full amount of all charges from Wireless Nation even if you dispute them. You must take up any disputes directly with Wireless Nation as outlined in their Terms of Service.
6. Wireless Nation reserves the right to change the terms of the plan, by giving you 30 days written notice, if their contract with PGG Wrightson ends.
7. This agreement is also subject to Wireless Nation's Terms of Service, which is available at www.wirelessnation.co.nz, except that your obligation to pay the charges under those Terms of Service is to PGG Wrightson not to Wireless Nation. When the Wireless Nation charges are debited to your PGG Wrightson Monthly Trade Account then PGG Wrightson's Terms of Trade also apply to the extent PGG Wrightson deems relevant. 8. You agree to indemnify PGG Wrightson in full against any claims whatsoever from Wireless Nation or from third parties, arising from this Invoice Payment Agreement and/or breach of Wireless Nation's Terms of Service.
